Sub.-: Regularization of Single Point supply

Ref: - MERC Order dated October 3, 2011 in Case No. 108 of 2011

This is with respect to above referred order, wherein Maharashtra Electricity Regulatory Commission (MERC) has held that such Single Point supply is illegal and thus directed all the Distribution Licensee's to regularize all such Single Point Supply, either through the "Distribution Franchisee (DF)" route or by providing independent electric connection to individual Consumer, who are at present fed through such single point supply.

At present you are availing power supply at "Single Point" for onward distribution (called "Sub-Distribution") to other customers / occupants / tenants / licensees /lessees (called "User") with sub-metering. These User are not registered as customers of Tata Power.

We request you to regularize all such Single Point Supply either by providing independent electric connection to individual Consumer or through the "Distribution Franchisee (DF)" route , who are at present fed through such single point supply.

We have been in touch with your office for regularizing this single point supply. Your office had indicated that you would prefer TATA Power to directly supply individual consumers in your premises by taking over assets already installed by you. We have completed the survey & valuation of assets. The detailed report has already been

We re-iterate that single point supply is declared as illegal by order of MERC. We will appreciate if you can advise us by 20th Jan 2016 about the offer given to you so that the regulatory non-compliance is regularized at the earliest.
