Rs.300/- per parcel

WRONG DEPOSIT OF PARCELS

For all the parcels not covered under Customs Notification and are deposited with BDB at Sahar / PCCCC, an amount of Rs.700 /- per parcel will be charged for storage upto seven days. From the Eight day Rs.250 /- per parcel per day will be charged as demurrage.

HEAVY PARCELS

Parcels in excess of 30 kgs.will not be accepted as there is no provision for handling the same at Strong Room at PCCCC and Sahar.

GOVERNMENT TAXES

Government Taxes will be levied on the above charges as applicable from time to time.
